We shall not be liable for any loss, damage or expense arising out of any access to or use of this site or any site either linked to or from it including, without limitation, any loss of profit, indirect, incidental or consequential loss.

These terms and conditions do not affect your statutory rights. To order goods through this website you should be at least 18 years of age and accept delivery worldwide. We will treat each order for goods as an offer by you to purchase the goods subject to these terms and conditions.

We reserve the right to make any changes and corrections to our site as and when we consider it appropriate and without notice.

Description of Goods: All images, descriptive matter, specifications and advertising on our site are for the sole purpose of giving an approximate description of the goods. Full detailed specifications are available from the manufacturer's brochures or their websites.
